### Objectives & Investment Policy

The aim is to increase the value of your investment over the long term and to earn income within the fund.

The fund is managed on a discretionary basis and invests in shares of companies listed on the principal stock exchanges in developed countries around the world. The fund invests in a broad and diverse group of smaller sized companies. The composition of the fund may be adjusted based on considerations such as the number of outstanding shares of public companies that are freely available to the investing public, the tendency of the price of a security/share to continue movement in a single direction, how readily available the shares are to buy and sell, and profitability.

No more than 20% of the fund's net assets will be invested, either directly or indirectly, in countries that are considered to be emerging markets.

The fund may use financial contracts or instruments (derivatives) to manage risk, reduce costs or improve returns.

Income is not distributed and is rolled up (accumulated) into the value of your investment.

You may sell your investment in the fund on demand on a daily basis.

### Risk and Reward Profile



The risk and reward category is calculated using historical data which may not be a reliable indicator of the fund's future risk profile.

The lowest category (i.e. Category 1) does not mean a risk-free investment.

The Fund is in Category 5 because of the high range and frequency of price movements (volatility) of the underlying investments referenced by the Fund.

The fund may invest in other underlying funds. The fund's performance, costs and risks will be affected by the underlying funds. There can be no assurance that the investment objective of the underlying fund will be achieved.

The fund's investments in shares are subject to issuer-specific risks, market risks, economic or political risks that may cause the share prices to fluctuate over time. This can affect the value of your investment in the fund.

The fund may invest in smaller companies. This carries a higher risk as shares of small companies are often more difficult to sell than those of large companies, and as a result their share price can fluctuate more. In general, smaller companies are also more vulnerable than larger companies to adverse conditions.

Where the fund uses futures or forward foreign currency contracts (derivatives), it may become exposed to certain investment risks including leverage, market, mismatching of exposure and/or counterparty risk, liquidity, interest rate, credit and management risks and the risk of improper valuation. While the fund is not expected to have exposure to leverage to a material degree, any movement in the price of these investments can have a significant impact on the value of the fund and the fund could lose more than the amount invested.

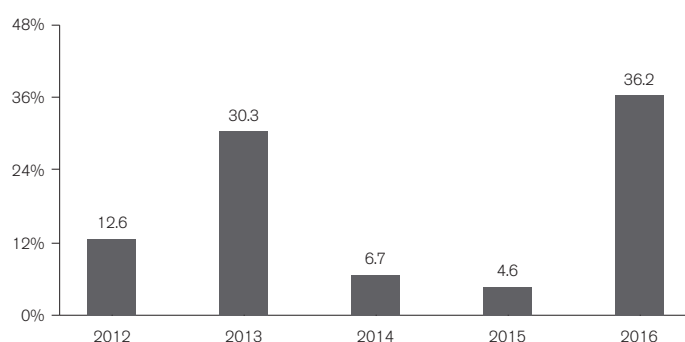
